## CAPE FINE & RARE WINE AUCTION BID MANDATE

If you are unable to attend the Cape Fine & Rare Wine Auction in person, bidding can be arranged on your behalf by completing the steps and required information below:

1. Email the completed mandate form provided below to the Auction Office by no later than 5 working days prior to the auction date.
2. Provided the duly completed mandate form is received on time, The Cape Fine & Rare Wine Auction will undertake the bidding on your behalf as per your stipulated requirements and in accordance with the Conditions of Sale published in the auction catalogue, which is available to download online at <http://capefinerarewine.auction/conditions-of-sale/>
3. The wine in each item will be auctioned in lots (or groups of lots) and it may not be possible to purchase the total number of cases stated on the mandate form. The purchase price will however not exceed the maximum amounts stated on the form.
4. Please ensure that you accurately record the lot numbers, descriptions, and maximum price you are willing to pay for each lot and that the bids are listed in the same order as the lots appear in the catalogue. "Buy" or unlimited bids will not be accepted.
5. Please place your bids as early as possible. In the event of identical bids, the earliest received bid will take precedence. Where appropriate, bids may be rounded down to the nearest amount consistent with the Auctioneer's bidding increments.
6. It is important to note that the auction does not facilitate split lots.
